## Foreign-Born Workers Awarded Retirement and Disability Benefits, 1978

A recently developed study file has enabled the Social Security Administration to examine the experience of foreign-born workers who were living in the United States at the time they began collecting benefits under the Old-Age, Survivors, and Disability Insurance program. Of the 1.9 million persons awarded retired-worker and disabled-worker benefits in 1978, about 88,000 were born outside the United States. They made up less than 5 percent of persons awarded retired-worker benefits (table 1) and about 4 percent of all disabled-worker allowances (table 2). Most of the foreign-born awardees had worked in Social Security covered employment since before 1960.

Data in the study file—a 4-percent sample of awards to retired and disabled workers in 1978—showed that, on the average, foreign-born beneficiaries were older than others at the time of award. The retired workers among them had higher average primary insurance amounts (PIA's) than did retired workers in general; a larger proportion of them were in the highest PIA cate-

gory. Among disabled workers, the foreign born had lower PIA's and fewer were in the highest PIA group.

The study file has been used to produce a 12-page report (with 20 detailed tables) on the status of foreignborn workers awarded retirement and disability benefits. Data are presented for all foreign-born retired and disabled workers. In most cases, data are also presented for those of European birth and for those born in Spanish-language countries. (The latter group includes persons born in Puerto Rico, who are U.S. citizens by birth, but who were included with the Spanish-language countries because Spanish is their primary language.) These groups are compared by age, race, and sex, as well as by average PIA and the distribution of their PIA's.

Persons born in Europe made up the majority of the foreign-born awardees. Compared with other foreign-born awardees, they were older at the time of award and received larger benefits. Hispanic workers, on the other hand, were younger than the average, and their benefit amounts were lower.
