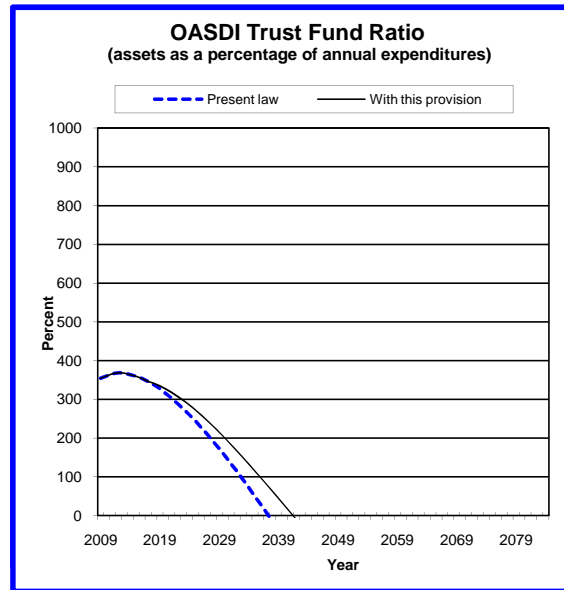
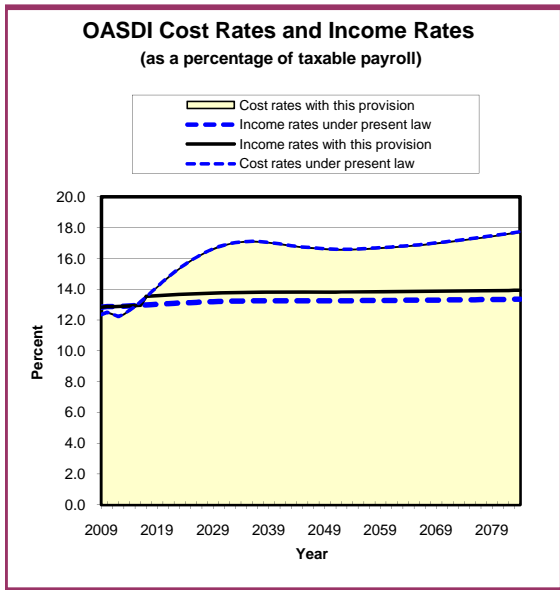


**Summary Measures and Graphs**  
**Category of Change: Payroll Taxes (including maximum taxable)**

*Proposed Provision: Apply 4 percent payroll tax rate on earnings over \$200,000 in 2017, with the \$200,000 threshold wage-indexed after 2017. Give no benefit credit for additional earnings in AIME for benefit computation.*
