

# Frequently Requested Social Security Administration Statistics

## Office of Disability Programs:

### 1) [SSA State Agency Workload Data](#)

This dataset includes monthly data from October 2000 onwards for SSA disability cases referred to the state agency for a disability determination. When first released, initial claims information was available, but now new information is included on reconsideration and continuing disability review cases, with breakouts by claim title (SSDI, SSI) for each case type. Specific data elements for each state are receipts, end of month pending counts, determinations, allowances, and allowance rates; and, organized by Region, State, Month, Initial, Reconsideration, and CDR.

### 2) [SSA Disability Claim Data](#)

The dataset includes fiscal year data for initial claims for SSA disability benefits referred to a state agency for a disability determination. Specific data elements for each year and state include receipts, determinations, eligible population, and favorable determination rates. The data may be used to examine disability application filing trends by time and by state, state agency workloads, and disability claims outcomes.

#### 1) [Annual Statistical Report on the Social Security Disability Insurance Program](#)

This annual report provides program and demographic information about the people who receive disability benefits. The following are the basic topics covered:

**Section 1 (Charts 1-6, Tables 1-30)** – Beneficiaries in current-payment status;

**Section 2 (Chart 7, Tables 31-34)** – Workers' compensation and public disability benefits;

**Section 3 (Charts 8-10, Tables 35-51)** – Benefits awarded, withheld, and terminated;

**Section 4 (Chart 11, Tables 59-64)** – Outcomes of applications for disability benefits; and

#### 2) [Income of Disabled-Worker Beneficiaries](#)

This chart book provides an overview of how important Social Security benefits are to disabled workers and their families. The charts focus on the following:

- Demographic and economic status of disabled workers and their families;
- The extent to which those families rely on Social Security, other disability payments, pensions, asset income, and earnings; and
- The role Social Security plays in reducing poverty.

#### 3) [OASDI Beneficiaries by State and County](#)

This annual publication focuses on the Social Security beneficiary population—people receiving Old-Age, Survivors, and Disability Insurance (OASDI) benefits—at the local level.

#### 4) [OASDI Beneficiaries by State and ZIP Code](#)

This annual publication focuses on the Social Security beneficiary population at the ZIP Code level. It presents basic program data on the number and type of beneficiaries and the amount of benefits paid in each state, Social Security Administration field office, and ZIP Code.

This volume combines much of the information on SSA's disability programs that is available in other publications. However, information from across decades of program data appears in a user-friendly format that is accessible to both the disability policy researcher and the interested private citizen. - Population factors influencing program size;
- Changes in program policy influencing program size;
- Changes in incentives influencing program size; and
- Projected future course for SSA programs.

This annual report presents data on the SSI program and the people who receive benefits from it. The report covers the following topics:

In addition, data are presented on the major health care programs—Medicare and Medicaid—and social insurance programs, including workers' compensation, unemployment insurance, temporary disability insurance, Black Lung benefits, and veterans' benefits.

This file contains two separate but linkable subfiles—one with benefit information and the other with longitudinal earnings information. Sample beneficiary records drawn from the Old-Age, Survivors, and Disability Insurance (OASDI) program can be linked to their corresponding earnings histories.

**19) [Earnings Public-Use File, 2006](#)**

The 2006 Earnings Public-Use File (EPUF) contains administrative earnings data (related to the Social Security program) and limited demographic data for more than 4 million individuals.

The NBDS, developed over the past decade, contains extensive information on the changing circumstances of aged and disabled beneficiaries.

The OASDI Public-Use Microdata File contains an extract of data fields from the MBR and consists of a 1 percent random, representative sample of persons entitled to receive an OASDI benefit payment for December 2001. This file contains approximately 460,000 records with 16 data fields on each record.

**23) [Supplemental Security Income \(SSI\) Public-Use Microdata File, 2001 Data](#)**

The SSI Public-Use Microdata File contains an extract of data fields from the SSR and consists of a 5 percent random, representative sample of persons who received a federal SSI benefit in December 2001. This file contains approximately 320,000 records with 13 data fields on each record.

Such benefits are paid to several [types of beneficiaries](#). [Supplemental Security Income](#) (SSI) benefits are paid from the general fund of the Treasury.

**2) [Beneficiary Databases](#)**

Benefit data, available for certain types of beneficiaries or "families," are collected on a monthly basis. Such data provide the number of beneficiaries and their average payment amounts.

SSA prepares and delivers this report to the President and Congress on an annual basis. The SSI includes:

- 25 year projections of future recipients and program costs;
- A historical summary of statutory changes to the SSI program;
- Historical and current data relating to various aspects of the SSI program;
- Summaries of any relevant research on the SSI program by SSA or others; and
- A statement on the SSI program from the Social Security Advisory Board.

## 10) CDR Report to Congress

Section 221(i) of the Social Security Act (Act) requires an annual report to Congress on:

- periodic CDRs mandated by the Social Security Disability Amendments of 1980; and
- determinations that the Commissioner of Social Security has made to waive the requirement that Social Security review the continuing eligibility of disability beneficiaries with nonpermanent disabilities at least once every 3 years.

Section 1614(a) (4) of the Act gives Social Security discretionary authority to conduct periodic CDRs on Supplemental Security Income (SSI) recipients.

## Office of Open Government:

### 1) [Disability Insurance Applications filed via the Internet - FY 2008-2011](#)

This dataset provides monthly data at the national level from federal fiscal year 2008 onwards for initial Social Security Disability Insurance (SSDI) applications filed via the Internet, and initial SSDI applications submitted via telephone, in person through a local SSA field office, or by mail that could be filed via the Internet.

### 2) [Disability Insurance Applications filed via the Internet - FY 2012 and onward](#)

In fiscal year (FY) 2012 we expanded access to our Internet services by launching additional Spanish language services, including a Spanish language online application for disability benefits. Also starting in FY 2012, online disability applications can be filed by claimants outside the United States. This dataset includes information about the original universe and the expanded access.

### 3) [Percentage of Fast-Track Receipts for Fiscal Year 2010 and 2011](#)

The dataset represents the agency's programmatic disability data used to administer the disability process and is published in official agency reports.

### 4) [Average Wait Time Until Hearing Held Report \(formerly NETSTAT Report\)](#)

A presentation of the average time (in months) from the hearing request date until a hearing is held for claims pending in the Office of Disability Adjudication and Review's hearing offices. Allows users to estimate the amount of time they may have to wait for a hearing to be held.
