Below are explanations of the group and column headers.

ALJ DECISIONS – AC actions taken on RRs of ALJ decisions (not dismissals) during the time period covered by the report.

ALJ DISMISSALS – AC actions taken on RRs of ALJ dismissals during the time period covered by the report.

NAME – Name of ALJ

OFFICE – Primary hearing office location.

RG – Region of hearing office location.

TOT RVW – Total RR actions disposed.

AGR – AC agreed with the ALJ action.

REM – AC remanded for further action by ALJ for reason(s) related to ALJ activity.

REV – AC revised the ALJ action and issued another disposition.

EXC – AC remanded for further ALJ action but for reason(s) unrelated to ALJ activity.
