## Statutory Reporting Requirements

On September 15, 2017, the President signed into law H.R. 624, the Social Security Number (SSN) Fraud Prevention Act of 2017, which became Public Law No. 115-59. The law, among other provisions, restricts the inclusion of SSNs on documents the Federal Government sends by mail and requires Federal agencies to issue regulations outlining when inclusion of the SSN is necessary on mailed documents within five years of enactment. Additionally, the law requires agencies to report to Congress about implementation efforts to remove SSNs from documents agencies send by mail, with the first report due 30 days after enactment and annually thereafter for five years. Accordingly, this fifth annual report includes an update on our implementation strategy and the title and identification number of each document with the full SSN the agency mailed in the previous year.

As part of our implementation strategy, we will remove and replace the full SSN with a beneficiary notice control number (BNC#) on each mailed document. The BNC# is a secure 13-character alphanumeric code used to identify a mailed document. Employees can use the BNC# to access authorized Intranet applications to identify the beneficiary and associated records after verifying the person's identity using agency authentication procedures.

We note that on some documents, we may remove the full SSN without replacing it with a BNC# as many of our mailed documents are informational. For disability determination services (DDS) related notices, we replaced the full SSN with a case number instead of the BNC# as provided for under our fiscal year (FY) 2020 efforts below.

### FY 2020 SSN Removal Activities

In FY 2020, we removed and replaced the SSN with a BNC# from over approximately 22 million mailed documents, including the following:

- Cost of Living Adjustment (COLA) Supplemental Security Income notices;
- Enhanced Leads and Appointment Confirmation System notices;<sup>1</sup>
- Representative Payee notices;
- Special Veterans Benefit notices;
- Supplemental Security Income print application notices; and

We also replaced the SSN with the case number on more than 1 million mailed documents in the disability case processing system (DCPS). DCPS does not include the SSN on its notices; rather, it uses a case identification number.

## **FY 2021 SSN Removal Activities**

In FY 2021, we removed and replaced the SSN with a BNC# from over approximately 8 million mailed documents, including the following:

- SSI StaRZ and StriPEs The Next Generation (SSTNG) notices;
- Internet Ticket Operations Provider Support Systems notices;
- Disability Control File/Ticket To Work notices;
- Employment Network (EN) notices;
- Vocational Rehabilitation (VR) notices; and
- eWork notices.

## **SSA Notice Inventory and Next Steps**

As required by P.L. 115-59, we have attached an inventory of all mailed documents that contain the full SSN. Currently, of the estimated 350 million documents we mail annually, less than one-half include the full SSN. We plan to remove the SSN from additional documents over the next year, which will leave us with about one-third of our documents containing the full SSN. We will not be able to eliminate the SSN from all agency documents we send by mail because certain uses of the SSN remain essential to our business processes.

## **Necessary Use of the SSN**

### ***Exception of Certain Mailed Documents***

It is important to mention the unique role of the SSN for SSA. We use the number to administer the Old-Age, Survivors, and Disability Insurance (OASDI) programs. We also use the number to administer the Supplemental Security Income (SSI) program, which provides monthly payments to people with limited income and resources who are aged, blind, or disabled.

We will issue a regulation within the prescribed statutory period that explains the circumstances under which the full SSN is necessary on certain mailed documents. We assign an exception number to categorize mailed documents by the reason it qualifies as an exception to removing the SSN.

***Exception Categories:***

- Exception 1: Social Security Cards;
- Exception 2: Applications, Application Summaries, Redeterminations, Reconsiderations and Appeals;
- Exception 3: Social Security Representative Payee Accounting Forms;
- Exception 4: Third Party Requestor Response Forms;
- Exception 5: Other mailed documents the Commissioner deems to be necessary to one or more business process;
- Exception 6: Earnings and Wage Reports; and
- Exception 7: Grant Access Requests and Requests to Disclose Records to a Third Party (with and without consent and about both living and deceased individuals).

We appreciate the opportunity to report on our implementation plan to remove SSNs from mailed documents.
