Dear Mr. Chairman:

I am pleased to submit our initial report, including our implementation plan for restricting the inclusion of Social Security Numbers (SSNs) on documents sent by mail, as required by the Social Security Number Fraud Prevention Act of 2017 (Public Law 115-59). I am also enclosing a listing that contains the title and identification number of documents with the full SSN displayed, used by our agency in the previous year.

We take seriously the public's concerns about mailing documents that include SSNs. Our report includes information on our prior and current efforts to eliminate and reduce the use of SSNs on our mailed correspondence. Our focus is to replace the SSN with a Beneficiary Notice Code that is unique to every mailed document we send.

First Annual Report On Removing Social Security Numbers from Mailed Documents

P.L.115-59



Fiscal Year 2017

Social Security Administration Report to Congress Removal of Social Security Numbers from Mailed Documents Required by P.L. 115-59

History of the Social Security Number

When the Social Security program was enacted under the Social Security Act of 1935 (Act), the Act did not mandate the use of Social Security numbers (SSNs). However, the Act did authorize the creation of a record-keeping system. A 1936 Treasury regulation provided that employees covered by the new program must apply to the Social Security Administration (SSA) for account numbers. Accordingly, in 1936, we designed the SSN and Social Security card to allow employers to uniquely identify, and accurately report, an individual's earnings covered under the new Social Security program. The Social Security Act currently mandates that we both assign SSNs and issue SSN cards in connection with our obligation to maintain our records. Today, over 80 years since the program's inception, we have issued approximately 500 million unique numbers to eligible individuals.

It is important to note that Congress did not intend for the Social Security card to serve, nor does it serve, as a means of personal identification. Although we have made many changes over the years to make the card counterfeit-resistant as required by law, and continue to work to strengthen its security, we encourage agencies and the public to minimize the use of Social Security cards whenever possible. To this end, we continue to expand electronic verification of the SSN with our Federal and State partners, to reduce unnecessary use of the card and provide better public service.

SSNs continue to be essential to how we maintain records for our programs; without them, we could not carry out our mission.

Currently, approximately 69 million individuals depend on the benefits we provide. In fiscal year (FY) 2017, we paid approximately \$934 billion to Social Security beneficiaries. Additionally, in FY 2017, we anticipated paying nearly \$57 billion in Federal benefits to a monthly average of over 8 million Supplemental Security Income (SSI) recipients. Of the estimated 350 million documents we mail annually to support our programs, about 233 million include full SSNs. These documents fall into two general categories – forms and notices. Mailed notices are our primary means of communicating with the public.

Efforts to Reduce the Use of SSNs on Mailed Documents

As the agency responsible for assigning SSNs and issuing Social Security cards, we are particularly aware of the effects of SSN misuse on the public. We are always looking for opportunities to increase the protection of SSNs. In the early 2000s, we began taking steps to remove or truncate SSNs where possible.

2001-2015: Annual Cost-of-Living (COLA) Adjustment Notices and Benefit Checks

Between 2001 and 2015, we removed the full SSN from two of our largest annual notice workloads: the Social Security Statements and Social Security COLA notices, which account for approximately one-third of the documents we mail each year.

On the *Statement*, we truncated the SSN and began displaying only the last four digits. This was a major step forward in protecting the SSN.

On the annual COLA notice, we began displaying a Beneficiary Notice Code (BNC). The BNC is an encrypted 13-character alphanumeric code, which is unique to each notice. Employees access a lookup tool to identify the beneficiary and associated records.

We also worked with the Department of the Treasury to remove the SSN from all Social Security and SSI benefit checks. Instead of the SSN, Treasury began including a check number assigned during payment processing.

2016-Present: Overpayment Remittance Forms and New or Modified Documents

In 2016, we convened an intra-agency workgroup to analyze options for removing the SSN from all agency documents, except those critical to delivering on our mission. The analysis resulted in an agency-wide decision to discontinue displaying the SSN on any new or modified notices.

In addition to removing the SSN on correspondence as resources permit, we are currently in the planning stage of redesigning our overpayment and debt collection systems. Recovering benefit overpayments represents another high-volume paper-based workload. The current process requires debtors to return remittances with an associated payment coupon, which includes the full SSN. As part of this initiative, we will replace the use of the SSN to identify the individual and associated debts.

Statutory Reporting Requirements

On September 15, 2017, the President signed into law H.R. 624, the Social Security Number Fraud Prevention Act of 2017, which became Public Law No. 115-59. The law, among other provisions, restricts the inclusion of SSNs on documents sent by mail by the Federal government. The law also requires Federal agencies to issue related regulations within five years of enactment, and report to Congress annually on implementation of efforts to remove SSNs from documents sent by mail, with the first report due 30 days after enactment and annually thereafter for five years.

As required by law, this first report includes our implementation strategy, as well as the title and identification number of each document with the full SSN used by the agency in the previous year. It is important to note that many of our notices are informational and as such do not contain corresponding identification numbers. Likewise, many of our mailed forms include a placeholder for the responder to include the full SSN.

Implementation Plan: Leveraging Our Information Technology (IT) Modernization Initiative

Beginning in FY 2018, we are launching an enterprise initiative—IT Modernization—to transform the way we design and build systems and ultimately enhance the way we serve the public. Among the overarching principles for the multi-year investments under IT Modernization, is the removal of SSNs from mailed documents.

As part of our IT Modernization initiative, we are holistically evaluating our communications infrastructure, with the primary objective of reducing the number of mailed notices we send to the public. Using new, agile systems, we will interact with our customers using their preferred medium while protecting their personally identifiable information. Near-term, we are prioritizing all agency notices for SSN removal based on volume.

SSN Removal Activities Scheduled for FY 2018

In concert with the Centers for Medicare and Medicaid Services' efforts to remove the SSN from Medicare cards, in FY 2018 we plan to replace SSNs with BNCs on benefit verification notices, which account for approximately 11 million mailed documents. We will also replace SSNs with BNCs on approximately 28 million Social Security post-entitlement notices, and on certain mailed documents sent to appointed representatives, which account for an additional 2.6 million mailed documents.

SSA Notice Inventory and Next Steps

As required by P.L. 115-59, we are attaching an inventory of all mailed documents that contain the full SSN. As previously noted, we began removing the full SSN from mailed documents in 2001, and have made recent progress in this area. However, by strategically leveraging our IT Modernization efforts, we anticipate the agency will be in a better position to efficiently remove SSNs from mailed documents that are not critical to our key business processes. Nevertheless, because certain uses of the SSN remain essential to our business processes, we may not be able to eliminate the SSN from all agency documents sent by mail.

Necessary Use of the SSN

It is important to recognize the unique role of the SSN for Social Security. We use the number to administer the Old-Age, Survivors, and Disability Insurance programs. We also use the number to administer the SSI program, which provides monthly payments to people with limited income and resources who are aged, blind, or disabled.

SSA will issue a regulation within the prescribed statutory period that explains the circumstances under which the full SSN is necessary on certain mailed documents that are critical to our key business processes. Examples of these documents include:

Social Security Cards

- Social Security Benefit Application Receipts
- Social Security Representative Payee Accounting Forms
- Direct Deposit Enrollment Forms
- Third Party Requestor Response Forms
- Other mailed documents deemed by the Commissioner to be critical to one or more business processes

We appreciate the opportunity to report on our implementation plan to remove SSNs from mailed documents.
