Pov Thawj Ntaub Ntawv Tsiv Teb Tsaws Chaw Txog Twg Lawm

Yog tias koj yog ib tug neeg kawm ntawv txawv tebchaws los yog tus neeg tuaj saib tebchaws, koj yuav tau muab ib co ntaub ntawv ntxiv, xws li cov ntawv Form I-20, DS-2019, los yog ib tsab ntawv tso cai ua haujlwm los ntawm koj lub tsev kawm ntawv thiab lub chaw haujlwm los (F-1) los yog tus neeg tos (J-1). Peb TXAIS TSIS TAU ib daim ntawv teev qhia tias koj tau ua ntawv thov daim ntawv. Yog tias koj tsis tau kev tso cai ua haujlwm hauv Tebchaws Asmeskas, peb tsuas muab tau ib daim npav Xaus Saus rau koj yog tias koj xav tau ib tug lej vim yog ib lo lus uas tsis yog kev ua haujlwm hais tias yog vim li cas nkaus xwb. Yog tias koj tsis tau muaj hnuv nyoog 18 xyoo, koj yuav xee npe koj tus kheej, los yog ib tug niam txiv los yog leeg muaj ntawv saib xyuas xee npe rau koj los tau. Muab khaws cia rau ib lub chaw ruaj khov thiab tsuas koj nrog koj thaum uas yuav tsum tau muab daim npav los qhia nkaus xwb; xws li mus ua ib txoj haujlwm tshiab, mus qhib ib lub chaw cia nyiaj tshiab, los yog mus muab cov txiaj ntsim kev pab los ntawm tej lub koomhaum nom tswv Asmeskas. Xyuam xwm thaum uas koj muab koj tus lej Xaus Saus rau lwm tus neeg, qhov tseeb yog thaum siv xov tooj, xa ntawv thiab kev thov hauv Internet uas koj tsis tau ua tus pib.

LO LUS NTAWM TXOJ CAI CEEV RAU YUS TUS KHEEJ Kev Sib Sau thiab Kev Siv Yus Tus Kheej Cov Ntaub Ntawv

Cov Tshooj Cai 205(c) thiab 702 ntawm txoj cai Social Security Act, raws li tau muab hloov ntxiv lawm, tau tso cai pom zoo rau peb sib sau cov ntaub ntawv no. Cov ntaub ntawv uas koj muab rau peb yuav muab siv los muab ib tug lej Xaus Saus rau koj thiab muab ib daim npav Xaus Saus rau koj.

Cov ntaub ntawv uas koj muab rau ntawm daim ntawv no yog koj yeem muab. Tiamsis, yog koj muab tsis tau cov ntaub ntawv uas peb tau thov nws yuav txwv peb txoj kev muab ib tug lej thiab daim npav Xaus Saus rau koj.

Peb yeej tsis tshua pom kev siv cov ntaub ntawv uas koj muaj rau daim ntawv no siv mus ua lwm txoj luag haujlwm uas tsis yog rau txoj kev muab tus lej thiab daim npav Xaus Saus rau koj. Tiamsis, tej zaum peb yuav siv los mus tswj thiab tuav lub koob ntawm cov kev pab cuam Xaus Saus.
