Commissioner Social Security Administration

Andrew Saul is the Commissioner of the Social Security Administration. He was sworn in on June 17, 2019 for a six-year term that expires on January 19, 2025.

From 2002 to 2011, Commissioner Saul served as the Chair of the Federal Thrift Investment Board (FTIB). He was nominated by President Bush and confirmed by the Senate, and served under President Obama. The Board administers the Thrift Savings Plan (TSP), which provides military and federal employees the opportunity to save for additional retirement security. During his chairmanship, the FTIB introduced the popular life cycle funds and increased TSP participation while substantially reducing participant costs.

In addition to Commissioner Saul's federal service, he has also served in state and local government, as well as, non-profit organizations. He has worked as Vice Chairman and Chairman of the Finance Committee of the New York Metropolitan Transportation Authority. Commissioner Saul also has served as Vice Chairman of the Mount Sinai Health System, and Chairman of its Audit and Compliance Committee. In addition, he was a Trustee and Chairman of the Audit Committee of the National Gallery of Art. He formerly served as a board member of the United Jewish Appeal Federation of New York.

Commissioner Saul also has substantial experience in the private sector. For twenty years, he managed two large publicly traded retail apparel chains. These chains grew into national retailers, including hundreds of stores and employing thousands of workers.

Commissioner Saul is a graduate of the Wharton School of Finance at the University of Pennsylvania.. He and his wife Denise have been married 50 years. They have two adult children, and three grandchildren.

Dr. Mark Warshawsky is Deputy Commissioner for Retirement and Disability Policy at the Social Security Administration where he leads policy development and research activities.

He was a Senior Research Fellow at the Mercatus Center of George Mason University from 2014 to 2017. He was director of retirement research at Towers Watson, a global human capital consulting firm, from 2006 to 2013.

Dr. Warshawsky was a member of the Social Security Advisory Board from 2006 through 2012 and was vice chairman of the federal Commission on Long-Term Care in 2013. He served as assistant secretary for economic policy at the U.S. Department of the Treasury from 2004 to 2006, playing a key role in the development of the Pension Protection Act of 2006. He was developer of planning software and an app for personalized retirement income strategies. He has held senior-level positions at the Federal Reserve Board, the IRS, and TIAA-CREF.

Mark is the author of over 150 published articles and four books, including as coauthor of the Fundamentals of Private Pensions, Ninth Edition (Oxford University Press, 2010) and author of Retirement Income: Risks and Strategies (MIT Press, 2012).

He received a B.A. with highest distinction from Northwestern University, and a Ph.D. in economics from Harvard University.

Before joining the Social Security Administration in 2019, Steve Rollins was the Director of the Pennsylvania Bureau of Disability Determination for more than four years. Mr. Rollins entered that position after owning and managing Rollins Law Office, where for 15 years he represented claimants for Social Security Disability Benefits at the administrative and federal court of appeal levels. He is former legal counsel to the United States Department of Health and Human Services Office of General Counsel. Mr. Rollins has lectured on Social Security law for the Pennsylvania Bar Institute, the Philadelphia Bar Institute, the Pennsylvania Trial Lawyers, the Pennsylvania State University Dickinson School of Law, and the National Organization of Social Security Claimants' Representatives, as well as for various support, insurance, and medical groups.
