Category of Change: Payroll Taxes (including maximum taxable)

Proposed Provision: E3.14. Eliminate the taxable maximum for the employer payroll tax (6.2 percent) beginning in 2026. For the employee payroll tax (6.2 percent) and for benefit credit purposes, beginning in 2026, increase the taxable maximum by an additional 2 percent per year until taxable earnings equal 90 percent of covered earnings.
