
## Summary Measures and Graphs Category of Change: Payroll Taxes (including maximum taxable)

Proposed Provision: Apply 2 percent payroll tax rate on earnings over \$300,000 in 2017, with the \$300,000 threshold wage-indexed after 2017. Give proportional benefit credit for additional earnings in AIME for benefit computation.
