Public Social Welfare Expenditures, Fiscal Year 1986 by Ann Kallman Bixby*

In fiscal year 1986, Federal, State, and local governments in the United States spent \$770.5 billion on the cash benefits, services, and administrative costs for public programs of direct benefit to individuals and families. Such social welfare expenditures included income maintenance, health, education, housing, and veterans' programs. These expenditures represented 18.4 percent of the gross national product (GNP) in 1986, and more than half of total government spending at all levels.

The social welfare expenditure data for 1986 differed little from those of previous years, and they reinforced a pattern that has been evident in the series since the late 1970's. The relative level of spending for social welfare remained generally stable over the years 1977-86, but its direction or emphasis changed. Table 1 shows this pattern with regard to the GNP.

With the exceptions of 1979 and 1983, total social welfare expenditures accounted for between 18.0 and 19.0 percent of the GNP from 1977 through 1986. However, the contribution of various kinds of social welfare programs to that stable percentage changed considerably. Table 2 shows several components of social welfare

The Old-Age, Survivors, and Disability Insurance (OASDI) program and the combined programs of Medicare and Medicaid represented growing shares of total expenditures during this period. In fact, publicly financed health care expenditures increased nearly 60 percent when measured as a percentage of all social welfare expenditures. At the same time, public aid (other than medical services) spending for such programs as Aid to Families with Dependent Children, Food Stamps, and Supplemental Security Income, declined from 9.7 percent of total expenditures to 7.2 percent. Unemployment Insurance expenditures declined from 4.3 percent to 2.4 percent, although the rate of unemployment was the same in 1977, 1980, and 1986. The increases in U.S. social welfare spending were thus primarily in the areas of retirement and health care programs, which reflects the national emphasis on programs for elderly and disabled persons during the past 20 years. The elderly, in particular, represent an increasing proportion of the population, and have greater need for health care than do younger age groups. The increasing age of the elderly is also a factor in the increase in health

care costs: In 1986, nearly 5 percent of the population was aged 75 or older.

The amount of public social welfare expenditures increased \$40.1 billion, or 5.5 percent, from 1985 to 1986 (table 3). Of that increase, 45 percent was in the category of social insurance, 30 percent in education, and 16 percent in public aid. Social insurance includes the OASDI and Medicare programs, and public aid includes the Medicaid program. Thus, the increases followed the pattern of observed growth in retirement and health costs noted above. Public housing, which received a decreasing share of resources in the 1980's, was the only category in which expenditures decreased from 1985 to 1986. Chart 1 illustrates the changes in the composition of social welfare expenditures by category from 1970 to 1986.

An examination of social welfare

expenditure data in per capita constant dollars-that is, with the effects of price and population changes removed-shows that expenditures in the "Health and medical programs" category increased the most from 1985 to 1986, 5 percent, followed by education at 4 percent (table 4). Health care costs in this series are distributed by the program category under which the expenditures are met. Thus, the Medicare program is assigned to the social insurance category, veterans' hospital care to the veterans' category, and so forth. The combination of all medical costs from all categories appears under the rubric of "All health and medical care." In 1986, this combination of health and medical care costs represented 24 percent of all social welfare expenditures and 4.5 percent of the GNP.

The Federal Government share of social welfare expenditures declined slightly in most categories in 1986

(table 5). The overall apportionment of responsibility showed little change, however. Education continued to be primarily a Statelocal responsibility, as social insurance and veterans' programs remained in the Federal domain. The broad category of "All health and medical care" continued to be more than 70 percent federally financed.

The years since 1980 have shown a decline in the percentage of government expenditures for social welfare purposes (table 6). Trust fund expenditures remained relatively stable over the period 1980-86; the decline in spending occurred in the area of discretionary funds. This is consistent with the observation of increased spending for the OASDI and publicly financed health care programs, which are paid for largely or entirely from trust fund monies.

Health care costs have become an important element of the U.S.



economy during the 1970's and 1980's. Table 7 shows that in 1986 the United States spent \$454 billion on public and private health care, an amount equal to more than 10 percent of the GNP. The increase in health and medical spending from 1985 to 1986 once again outdistanced the increase in the general cost of living-8.2 percent, compared with 1.9 percent. Private health care spending continued to account for nearly 60 percent of the total, with the bulk of that money going for health and medical services.
