## Why do we need scam awareness?

Social Security takes protecting your personal information seriously. We are aware that there have been many scammers pretending to be government employees, and it continues to spread across the United States. We are working with Social Security's Inspector General to:

- Inform and educate the public about scams.
- Teach the public how to avoid scams.
- Encourage people to report scams.

## What is Slam the Scam Day?

National "Slam the Scam" Day is designated by Social Security's Inspector General to raise awareness of government imposter scams, which continue to spread across the United States. **Slam the Scam Day is Thursday, March 10, 2022**, as part of [National Consumer Protection Week](#), which takes place this year from March 6–12.

## What is the message?

Be very cautious of calls or emails from a government agency telling you about a problem you don't recognize. Real government officials will NEVER:

- Threaten arrest or legal action against you if you don't immediately send money.
- Promise to increase your benefits or resolve identity theft if you pay a fee or move your money into a protected account.
- Require payment with retail gift card, wire transfer, internet currency, or by mailing cash.
- Send unsolicited texts or emails that contain your personal information.

If you ever owe money to Social Security, the agency will mail you a letter with payment options and appeal rights. Social Security doesn't suspend Social Security numbers or demand secrecy from you to resolve a problem—ever.

# SCAM ALERT



Securing today  
and tomorrow

The Social Security Administration will never threaten, scare, or pressure you to take an immediate action.



## If you receive a call, text, or email that...

- Threatens to **suspend your Social Security number**, even if they have part or all of your Social Security number
- Warns of **arrest or legal action**
- Demands or requests **immediate payment**
- Requires payment by **gift card, prepaid debit card, Internet currency, or by mailing cash**
- Pressures you for **personal information**
- Requests **secrecy**
- Threatens to **seize your bank account**
- Promises to **increase your Social Security benefit**
- Tries to gain your trust by providing **fake "documentation," false "evidence," or the name of a real government official**

...it is a **scam!**

**Do not give scammers money or personal information – Ignore Them!**

## Protect yourself and others from Social Security-related scams

- **Try to stay calm.** Do not provide anyone with money or personal information when you feel pressured, threatened, or scared.
- **Hang up or ignore it.** If you receive a suspicious call, text, or email, hang up or do not respond. Government employees will not threaten you, demand immediate payment, or try to gain your trust by sending you pictures or documents.
- **Report Social Security-related scams.** If you receive a suspicious call, text, or email that mentions Social Security, ignore it and report it to the SSA Office of the Inspector General (OIG). Do not be embarrassed if you shared personal information or suffered a financial loss.
- **Get up-to-date information.** Follow SSA OIG on Twitter @TheSSAOIG and Facebook @SSA Office of the Inspector General for the latest information on Social Security-related scams. Visit the Federal Trade Commission for information on other government scams.

**¡Si recibe una llamada, un mensaje de texto, o un correo electrónico que...**

- Amenaza con **suspender su número de Seguro Social**, incluso si tienen parte o la totalidad de su número de su Seguro Social
- Advierte el **arresto u acción legal**
- Exige o solicita un **pago inmediato**
- Requiere un pago con una **tarjeta de regalo, una tarjeta de débito prepagada, dinero electrónico, o dinero en efectivo por correo**
- Presiona para obtener su **información personal**
- Solicita **confidencialidad**
- Amenaza con **embargar su cuenta bancaria**
- Promete **aumentar sus beneficios de Seguro Social**
- Trata de ganarse su confianza proporcionando «**documentación**» **falsa**, «**evidencia**» **falsa** o el **nombre real de un funcionario del gobierno**

**...es una estafa!**

**¡No de dinero u información personal a los estafadores Ignórelos!**

**Protéjase a usted y a los demás de las estafas relacionadas con el Seguro Social**

- **Trate de mantener la calma.** No proporcione dinero o información personal a nadie cuando se sienta presionado, amenazado, o asustado.
- **Cuelgue o ignórelo el teléfono.** Si recibe una llamada, mensaje de texto o correo electrónico sospechoso, cuelgue o no responda el teléfono. Los empleados de gobierno no lo amenazarán, exigirán un pago inmediato ni intentarán ganarse su confianza enviándole fotografías o documentos.
- **Reportar estafas relacionadas con el Seguro Social.** Si recibe una llamada, mensaje de texto, o correo electrónico sospechoso que menciona el Seguro Social, ignórelo, y denúncielo a la Oficina del Inspector General (OIG) de la administración del Seguro Social (SSA). No se avergüence si compartió información personal o si sufrió una pérdida financiera.
- **Obtenga información actualizada.** Siga a SSA OIG en Twitter @TheSSAOIG y Facebook @SSA Office of the Inspector General para obtener la información más reciente sobre estafas relacionadas con el Seguro Social. Visite la Comisión Federal de Comercio para obtener información sobre otras estafas.
